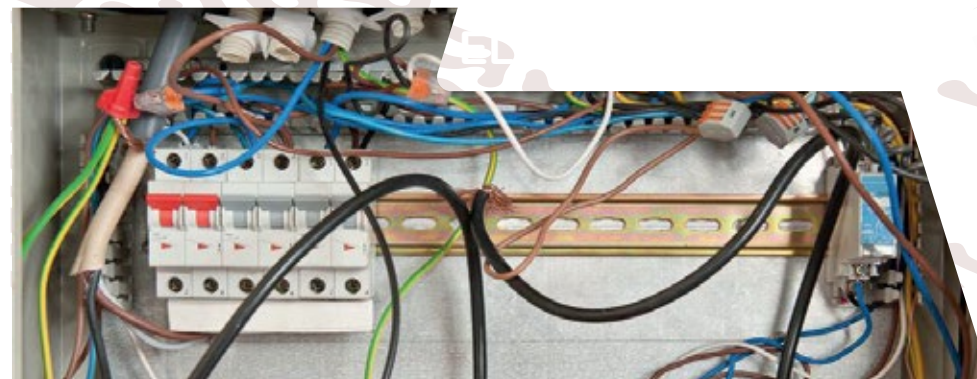

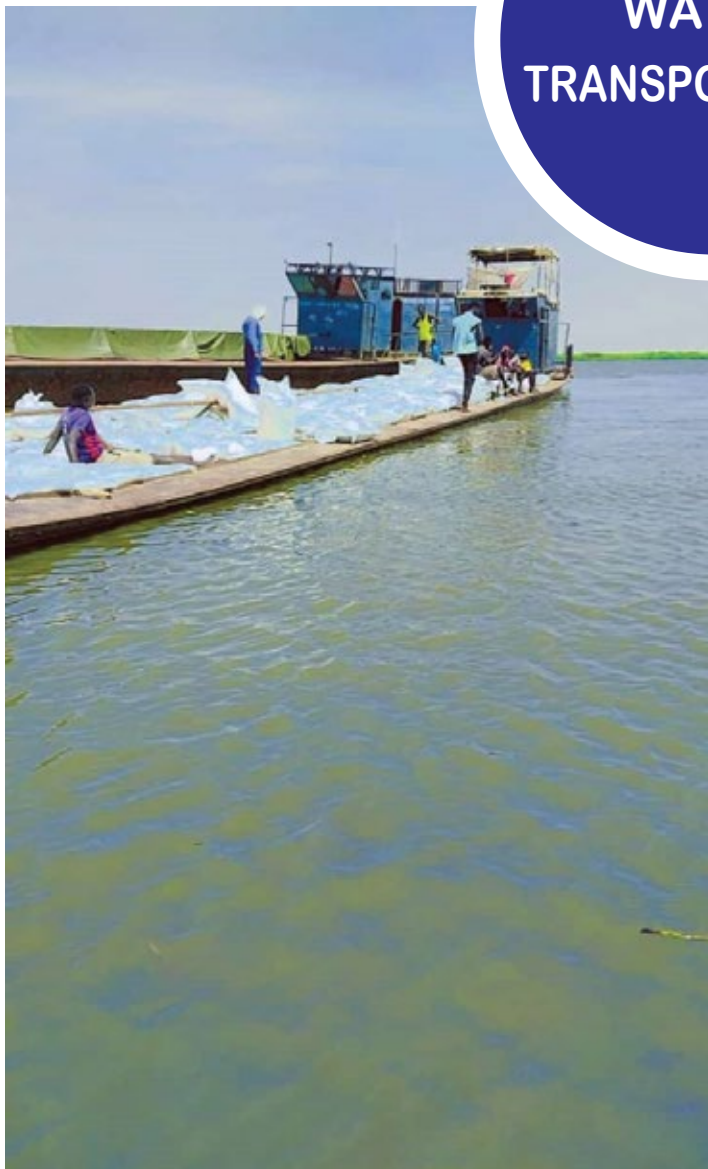

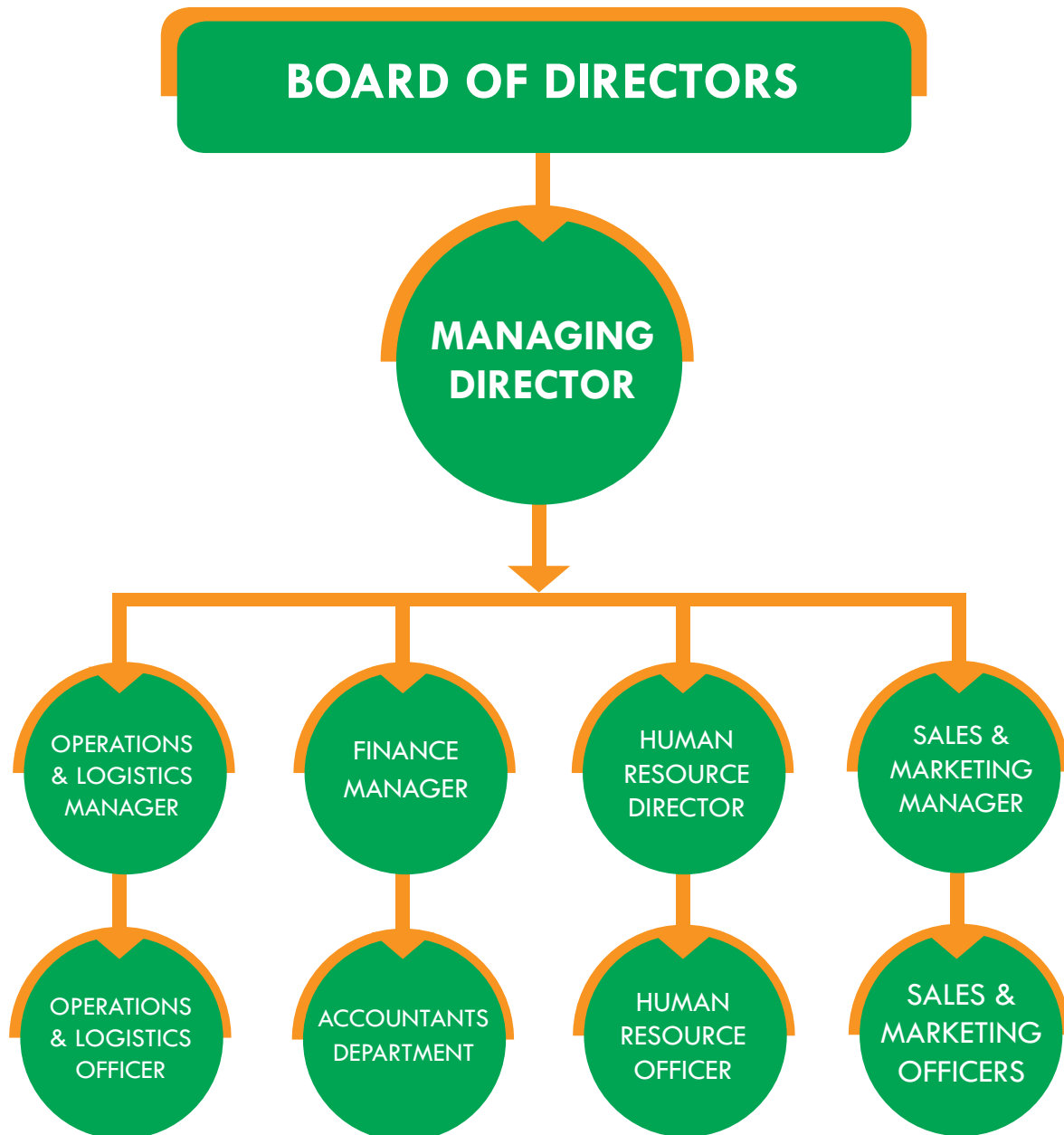
Environmental Responsibility.
